PRE QUALIFICATION CRITERIA (PQC)

The Bidders Pre-qualification criteria (PQC) shall be:

A - Technical:

1. The Bidder should be a company registered in India under the Companies Act, 1956 and should be in operation for at least the last 5 years on the date of bid submission. (Copy of Incorporation certificate should be attached).
2. Bidder should be Oracle authorized partners for Software update and product support (ATS of OEM) for Oracle database Enterprise Edition. The bidder has to be authorized by Oracle (OEM) to quote for the subject enquiry. Authorization letter/mail from OEM is required to be submitted by bidders.
3. The bidders must have successfully executed Purchase order(P.O.) for Software update and product support (ATS of OEM) for Oracle database Enterprise Edition in different organizations/companies/corporates, within last Seven (7) years, as follows:
 - One (1) Contract / P.O. of value not less than ₹ 6.60 lakh
or
 - Two (2) Contract / P.O. of value not less than ₹ 4.10 lakh each
or
 - Three (3) Contract / P.O. of value not less than ₹ 3.30 lakh each

The bidder is required to submit following documents to meet above criteria.

- Copy of purchase Order
- Completion certificate / Performance certificate.

B - Financial:

5. Average Annual Financial turnover during the last 3 years, ending 31st march 2017, should be at least ₹ 2.48 lakh.
6. Net worth shall be positive as on 31st March 2017.

To meet the above criteria, the bidder is required to submit copy of Audited Annual Report (Balance Sheet and Profit & Loss account) or Chartered Accountant's certificate for net worth and turnover for the last 03 (three) financial years.
